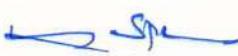

The Executive Council shall be the principal executive body of the University. The administration, management and control of the University and the income thereof shall be vested with the Executive Council which shall control and administer the property and funds of the University. The Executive Council, subject to the provisions of U.P. Private University Act, 2019 have the following powers and duties:-

- to hold and control the property and funds of the University;
- to acquire any movable or immovable property on behalf of the University;
- to make, amend or repeal Statutes and Ordinances;
- to administer any funds placed at the disposal of the University for specific purposes;
- to approve the budget of the University;
- to institute scholarships, fellowships, bursaries, medals and other rewards in accordance with the Statutes and Ordinances;
- to appoint Registrar, officers, teachers and employees of the University and define the duties and conditions of their service;
- to fix the honorarium, emoluments, traveling and other allowances of the examiners;
- to direct the form and use of the common seal of the University;
- to regulate and enforce discipline among members of the teaching, administrative and other staff of the University in accordance with the Statutes and Ordinances;
- to manage and regulate the finances, accounts, investments, property and all other administrative affairs of the University;
- to invest any money belonging to the University including endowed property;
- to provide the buildings, premises, furniture, equipments, apparatus and other means needed for carrying on the work of the University;
- to enter into, vary, carry out, and cancel contract on behalf of the University;
- to regulate and determine all other matters concerning the University in accordance with this Act, the Statutes, the Ordinances and the Regulations.

Every decision of the Executive Council shall be informed by the reasons therefor.

Quorum of the meeting of the Executive Council shall not be less than six members.

Decisions at any meeting of the Executive Council shall be taken by majority of the members present at such meeting:

Provided that, in case of tie in any proposal, the proposal having support of the Vice-Chancellor shall prevail.
