



- a. To provide means for giving education especially technical, medical, vocational and non-technical education in healthy surroundings and Research Institutes to spread advance science and Technical knowledge.
- b. To help, aid, assist, undertake, organise establish and maintain school, colleges, educational institutions or centers for imparting general professional, vocational, industrial, technical, physical, intellectual and moral education and to promote the advancement of education, art science and health and to assist and provide financial assistance for any other cause of general public utility not involving any activity for profit.
- c. To establish hospitals, clinics, sanatorium and convalescent homes for the practice of medicine with upto date facilities and to maintain or give grants to any dispensary, hospitals, maternity home women's hospitals, sanatorium, convalescent homes and child welfare centers or to establish, provide and meet cost for beds in any hospital or sanatorium and arrange for the maintenance thereof, for the benefits of the public in general.
- d. To maintain, contribute or to give aid to any Engineering, Medical, Educational or Social Institutions or Any Charitable Institutions with a philanthropic purpose which may in general interest of the poor and the destitute and to do all such acts and things with the object of giving relief to the poor.
- e. To engage teachers, professors, instructors and experts of good moral character and capable to impart efficiently and economically up-to-date instruction to students in modern sciences, industrial avocations, research work, technical, intellectual and other usual pursuits.
- f. To found, assist, support, establish and maintain libraries and reading rooms and to establish, maintain and run a boarding houses and hostels and assist such institutions.
- g. To provide for endowments, stipends, scholarships and other allowances to the poor deserving or needy students and for the promotion and encouragement of all types of education.

s. For removal of the doubt it is hereby declared that this Trust, it's object and implementation shall not be for the benefit of any particular cast, creed, community or religion. The College, research institute, hostel boarding houses library shall serve the eligible and deserving person without any discrimination of cast, creed, community or religion.

t. To encourage the youth to develop the awareness of education & career consciousness, to sponsor scholarship and nationwide /foreign trips to develop a modern and internationally compatible academic environment and research.

u. To possess a prosperous library with modern and rare and hardly available books and other sources of knowledge.

v. To do all other such acts and things which are incidental or conducive to the attainment of the above objects, specified hereinabove and promoting the general welfare and well-being of the society and uplifting the social, educational, cultural or economic condition of the masses.

PROVIDED that if any one or more of the purposes or objects specified in this clauses are held not to the purpose or objects of a Public Charitable nature, the Trustees shall not carry out such purpose or objects and the validity of the trust created by these presents as a trust for public charitable object or purpose shall not be affected in any manner.

THE trust shall in furtherance of all or any of its OBJECTS shall:

a. To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this deed.

- e. Purchase, take on lease, exchange, hire accept as a gift or otherwise, acquire land and/ or building or deal in any movable or immovable property or rights therein or privileges attached thereto which may be necessary or expedient for the attainment of its objects.
- f. Publish books, Journals, Literature and News Papers and reprint scriptures.
- g. To borrow money from Bank and other financial institutions or persons, to mortgage property of the Trust for raising of the funds to fulfill the object of the Trust.
- h. To accept donations, grants, presents and other offerings in cash or in any kind for the purposes of the Trust.
- i. To enter into contract and arrangement of all kinds.
- j. To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institutions, societies, organizations or trustees to start maintain or carry out such charitable objects.

5. AMENDMENT

That amendment to the SHRI RAJENDRA KUMAR GUPTA MEMORIAL TRUST shall be made with the majority in written of the Trustees of SHRI RAJENDRA KUMAR GUPTA MEMORIAL TRUST for the time being.

6. BOARD OF TRUSTEES

The Settlers of the trust shall be the first board of trustees of the trust namely Sh. Mukesh Kumar Gupta, Smt. Sandhya Gupta, Sh. Yogesh Kumar Gupta, Smt. Indira Devi and Shri Pramod Rana.

7. CESSATION & RETIREMENT

That the number of the trustees of SHRI RAJENDRA KUMAR GUPTA MEMORIAL TRUST shall always be at least three. In case of death or resignation of any trustee, the remaining trustees shall appoint his/her substitute, if they think fit for so.

It is clarified that in case of resignation/death of the Trustee, no nominee shall be entitled to be co-opted as Trustees unless accepted majority by rest of the Trustees. Otherwise such nominee of resignation trustee (or in case of death) shall have no claim over Trusteeship of the Trust.

If a trustee for the time being, resigns of his/her own free will or become as insolvent or of unsound mind or is held guilty of any offense involving moral turpitudes or fails to attend three consecutive meeting of the trust without leave of absence or reasonable cause, he/she shall deemed to have retired, subject to the confirmation of the board of Trustees in majority.

8. OFFICERS

All the five Trustees of Shri Rajendra Kumar Gupta Memorial Trust be the Board of Trustee, the detail of first post are given below. These posts shall rotate after every five year amongst them so that after 25 years same post is held by the same Trustee. The charter (first) post holders in shall be

Joint Secretary	: Sh. Yogesh Kumar Gupta
Treasurer	: Sh. Pramod Rana
Joint Treasurer	: Smt. Indira Devi

However, if any post holder doesn't want to rotate their post, the remaining shall appoint other one on the same in majority decision, with the consent of the same Trustee.

In the event of any vacancy arising on account of resignation or any other cause, of any office bearer, the board of trustees shall elect the new office bearer in his/her place from amongst themselves. Hence, an office bearer shall hold one or more post of the board.

9. QUORUM

The quorum of the meeting of board of trustees shall be 60%. All the decisions of the board of trustees shall be taken in majority.

If at a regular meeting no quorum is present within half an hour of the time fixed for the meeting, the meeting shall stand adjourned to next day to be held on the same time and the same place. At such adjourned meeting the quorum shall be 3 Trustees personally present.

In the case of a requisitioned meeting, if the quorum is not present within half an hour from the time fixed for such meeting, the same shall stand cancelled automatically.

10. **MEETINGS**

- a. The board of trustees shall hold at least 2 meetings annually. One of which shall be annual meeting wherein the budget of that Year and expenditures of the previous year shall be submitted.
- b. The president of board of trustees shall call the meeting. Seven days notice by personal notice or by registered post of the meeting shall be necessary. The secretary of board of trustee shall cause a minute book of the proceedings of the meeting of board of trustees to be maintained. An Emergent Meeting may, however, be called at a shorter notice. The notice of meeting shall specifying time, date and venue of such meeting as may be decided.
- c. The trustees shall establish the series of educational institutes and any initial cost of establishing such Institution/college/school shall be met from the money described in the first schedule and if such money is not sufficient, from such securities or loan, donation etc. as the trustees may consider it necessary for the purpose.
- d. The Chairman/ Secretary call a meeting of the Trustees on the requisition made to either of them in writing by any 2/3rd of the Trustees for the time being specifying the purpose for which such meeting is desired to be held. In the event of no meeting being called and held within twenty-one days from the receipt by them of such requisition, the said requisitionists may themselves call a meeting.
- e. That it is reiterated that Board of the trustees of the Shri Rajendra Kumar Gupta Memorial Trust shall be supreme Governing Body of the all the Institutes, which shall be establish under this trust deed, Hostel, Boarding House etc. establish or run by at and it's Fund. Management of Various Institute and Colleges, hostel establish or run by the Board Trustees shall work under supervision, control and direction of the Board of Trustees. No person or body shall have the power to alter this Supremacy.
- f. The Board of trustee shall have the power and discretion to accept any donation or contributions (Whether such donation or contributions be in cash or in form of immovable or movable property).

11. POWER & DUTIES OF THE TRUSTEES:

- a. The trustees shall purchase a piece of land and shall erect a building suitable for Institute/ College/ School, Hostel and Boarding House in accordance with the plan passed by the competent authority.
- b. The Board of Trustees shall have the power to receive and accept Contributions, Subscriptions and donations in the shape of cash or kind, securities/ shares and debentures of joint stock companies, movable or immovable property of free hold or any other kind on such terms and conditions as they may think fit, not being inconsistent with these presents of the trust hereby established.
- c. The board of Trustee may borrow from any Trustee of these presents and from Banks, Financial Institutions and from any other source such sum or sums of money as they may think necessary for the purposes of the Trust hereby created.
- d. The trustees shall employ such staff as they think necessary for giving Technical, Non-Technical and Vocational Education to the students as well as to develop their physique and character on such salaries as they think fit and replace them whenever they think necessary. The trustees shall also employ and remove other servants which they consider necessary for the purpose.
- e. Out of the income of the trust fund the trustees shall defray the expenses for running the Institute/College/school, Hostel and Boarding House as aforesaid and expenses for erecting building of the Institutes/ College/ School, hostel and Boarding House, but if the income is insufficient for that purpose the trustees may use such portion corpus of the Trust Fund as may be necessary.
- f. The trustees shall have the power to borrow money on the security of trust property and to alienate the trust property for necessary purpose.
- g. The trustees may invest the surplus fund in their hands in such securities as they deem fit.
